## TRAVEL INSURANCE – PLEASE READ!

Every year, a few people have to cancel their trip and incur a financial penalty. Trip Leaders cannot always find a last minute replacement the Club generally cannot 'swallow' the loss. We've also had members sustain an injury or illness during the trip and they've incurred significant medical expenses. Travel insurance can offset these risks at a cost of 5 to 15 percent of the total cost of your trip.

## Many products waive pre-existing conditions and offer additional "Cancel For Any Reason" coverage, but only if you purchase coverage within 15-21 days of your deposit.

The trip leader or the club *will not* purchase nor collect money for your trip insurance; each person can purchase coverage individually if they so choose. Nowadays, there are plenty of options:

- <u>Travel Guard</u> is recommended by previous tour operators our club has used. Travel Guard's All Seasons Travel Plan costs 7% of your total trip cost. They also offer a Cancel For Any Reason plan which costs ~11%. You may learn more or purchase the policies at <u>http://www.travelguard.com</u> or you may call Travel Guard at 877-249-5376.
- Alternatively, the websites <u>SquareMouth</u> and <u>Insure my Trip</u> (<u>http://squaremouth.com</u>), (<u>http://www.insuremytrip.com/</u>) compare hundreds of plans and might offer options or prices better suited to your needs.
- 3. Finally, many credit cards, and organization like AAA and AARP have their own offerings for the members.

We have had several cases in the past 2 years where members had to cancel their trip at the last minute. Please consider purchasing trip insurance to protect yourself!
