## TRAVEL INSURANCE - PLEASE READ!

Every year, someone has to cancel their trip for one reason or another, and unfortunately, it is not always possible to find a suitable replacement at the last minute, and the Club is not always in a position to refund all the money. Rarely, but surely, someone is injured or becomes sick during the trip and incurs significant medical expenses. The travel insurance can offset these risks at the cost between 5 percent and 15 percent of the total cost of your trip.

**Many products “waive” pre-existing conditions and offer additional “Cancel For Any Reason” coverage, if you purchase coverage within 14-21 days of your deposit, but only then.**

No coverage is included in the trip package price, but the tour operator is offering a Travel Protection Plan at the price of 6% or so depending on your age of your total package price; cancel for any reason coverage is available as well. You can review and purchase the insurance at <https://purchase.april-usa.com/alp/single-trip> . Please make sure to enter Snow Searchers Ski Club in the field for Booking ID/Number.

Otherwise, you can purchase coverage individually if you so choose. Here are few additional options:
