#### 3. TRAVEL INSURANCE PLEASE READ!

Every year, someone has to cancel their trip for one reason or another. Unfortunately, it is not always possible to find a suitable replacement at the last minute, and the Club is not always in a position to refund all the money. Occasionally, someone is injured or becomes sick during the trip and incurs significant medical expenses. The travel insurance can offset these risks at a cost of between 5 percent and 15 percent of the total cost of your trip. Many products "waive" preexisting conditions and offer additional "Cancel for Any Reason" coverage, if you purchase coverage within 21 days of your deposit. The trip leader or the club will not purchase nor collect money for your trip insurance; but each traveler may purchase coverage individually if they so choose. Here are few of the options:

- Our tour operators have often recommended the company Travel Guard for trip insurance. You may learn more or purchase the policies at <a href="http://travelguard.com">http://travelguard.com</a>, or you may call them directly at 877-249-5376.
- Alternatively, aggregate sites such as SquareMouth (<u>http://squaremouth.com</u>) or Insure My Trip (<u>http://www.insuremytrip.com/</u>) allow one to compare hundreds of plans from the top providers and buy immediately. You may find options or prices better suited to your needs.
- Finally, many credit cards, and organization like AAA and AARP have their own trip insurance offerings for the members.

**4. Warning:** Trip participants agree and understand that both traveling and skiing can be hazardous. Trip participants acknowledge that the SSSC and/or our tour operator Winter Ski & Sport is not responsible for the consequences of any such hazards. With regard to skiing, trail and slope conditions vary constantly because of weather changes and skier use. Bare spots, ice, variations in terrain, moguls, rocks, stumps, forest growth, debris, lift towers, snowmaking equipment, and other obstacles exist throughout the area. Each skier understands that it is his/her sole responsibility to ski in control and to avoid obstacles and hazards, including other skiers or snow grooming equipment. Trip participants acknowledge that falls and collisions also occur, and injuries often result. Trip participants understand and agree that Winter Ski & Sport is not responsible for and assumes no liability for such risks or dangers encountered on the trip. Participants in the trip assume any and all of such risks and agree to uphold SSSC and/or Winter Ski & Sport harmless from any claim resulting from any such loss or damage.

**5. Children:** Each trip participant represents that he/she has reached the age of majority, has read and understands the foregoing terms and provisions, and agrees to be bound thereby as a condition to participating in the trip. The parent or legal guardian of any trip participant who is a minor agrees that both such child and the legal guardian shall be bound by the terms and provisions set forth herein. And that parent or legal guardian agrees to hold SSSC and/or Winter Ski & Sport harmless from any claim by such minor resulting from any loss or injury.
